This newsletter will be followed in a few days with a short, electronic survey from pastor@laketoxawayum c.org (powered by **Survey Monkey) to get** your input. Please be honest in your responses because we want to truly understand the congregation's sentiments on this matter. To move to a vote for disaffiliation, we would need to have consent from our **District Superintendent,** Dr. Mark Rawls, with significant indication we have a 2/3 margin of individuals connected as full members ready to be physically present at a meeting and ready to vote for disaffiliation.

Disaffiliation Communication

This special Winter edition of LTUMC Newsletter focuses on issues of conflict that are and have been going on within The United Methodist Church for 50 years. In 1972 The United Methodist church banned the ordination of gay and lesbian clergy in the church's Book of Discipline. Since that time the issues of conflict around human sexuality have only intensified and become so deep that today they are unreconcilable.

The links to six articles chosen for this newsletter allow you, the reader, to get as much information about this subject of conflict within the church as you care to have. The articles are sequenced so that if you only choose to read first or second articles, you will get a good overview, or you can go deeper, reading as much as you like. One word of caution, if you choose to turn to the internet for additional reading, make sure that you understand the source of information on this subject and what their special interest might be. Much of the internet content on this subject matter is exaggerated, overstated, and out of context. The articles presented here have been chosen because they are objective, and fact based.

The first article What's next as NC churches leave the United Methodist fold? | Raleigh News & Observer (newsobserver.com) is from the Raleigh News & Observer. The article is dated in late November 2022 and provides a good overview of what is going on with The United Methodist Church in the North Carolina Conference.

The second article <u>Is The United Methodist Church really...? (Part 1)</u> (<u>umc.org</u>) is from The United Methodist Church and responds to basic questions from congregants about what is going on within the church and what is not. The next article <u>Is The UMC really...? (Part 2)</u> is also from UMC and is of a similar format. This article deals with the specific issues around human sexuality that are causing the conflict within the church.

The third article What should United Methodist congregations know about disaffiliation? (umc.org), also from UMC, breaks down the mechanics of disaffiliation from The United Methodist Church and what is required of churches that choose to pursue disaffiliation. And finally, the last two articles Is The United Methodist Church really...? (Part 3) (umc.org) and Is The United Methodist Church really...? (Part 4) (umc.org) use the same format to answer questions that the church has received from congregants about disaffiliation and other related topics.

You probably have questions regarding the topic of disaffiliation within The United Methodist Church and the leadership of LTUMC wants to give you a forum to get those questions answered. To do just that, we are dedicating the covered dish dinner scheduled for January 10th to have an open discussion of these issues and give everyone an opportunity to ask questions of Marcus and the leadership. If you are out of town and cannot attend the covered dish dinner then perhaps you can call in on a Zoom call scheduled for Friday, January 13th at 9:00AM. Both opportunities together should give everyone in the congregation an opportunity to get their questions answered.

The leadership of LTUMC has been staying abreast of the issues and conflicts surrounding human sexuality within The United Methodist Church. As part of the Administrative Council, the leadership body of LTUMC, we have had numerous discussions about the issues and the process of disaffiliation available to local churches, also called Paragraph 2553 provision. At this time, we do not believe that it would be in the best interest of LTUMC to pursue disaffiliation from The United Methodist Church.

Lake Toxaway United Methodist Church has been deeply rooted in The United Methodist Church for as long as anyone can remember, and probably since its inception. These are difficult times for The United Methodist Church, but the conflict is not new and has been with us since the church banned the ordination of gay and lesbian clergy in 1972. The governance processes of the church have not handled this issue very gracefully, but we have hope that the issues will be resolved in the next few years.

The process of disaffiliation would be very disruptive for our church. Churches that have gone through the process have found it to be very divisive and at its conclusion these churches have lost many members. We would like to minimize that outcome for LTUMC. God's work at LTUMC is alive and well and church leadership believes that it is in the best interest of LTUMC to stay the course and not disrupt the good work of the church.
